Safety Precautions

Read these safety instructions before using your device and store them for possible future reference.

- The device is not intended for use by persons (including children) with reduced physical, sensory or mental capacity. Persons who have not read the manual, unless they have received explanations by a person responsible for their safety and supervision should not use this unit.
- Children should be monitored to ensure that they do not play with the device.
- The device should always be readily accessible.
- The device should not be exposed to dripping or splashing water.
- No objects filled with liquids such as vases shall be placed on the device.
- Always leave a minimum distance of 10 cm around the unit to ensure sufficient ventilation.
- Open flame sources, such as candles, should not be placed on top of the device.
- The device is intended for use only in a temperate climate.
- At full volume, prolonged listening to the portable audio device may damage the user's hearing and cause hearing troubles (temporary or permanent deafness, hearing drone, tinnitus, hyperacusis).
- So, we recommend not to listen to the portable audio device at high audio volume and no more than one hour per day at medium audio volume.
- CAUTION: Danger of explosion if battery is incorrectly replaced or not replaced by the same type or equivalent.
- The battery should not be exposed to excessive heat such as sunshine, fire or similar.
- Different types of batteries, new and used batteries should not be mixed.
- The battery must be installed according to the polarity.
- If the battery is worn, it must be removed from the product.
- The battery must be disposed of safely. Always use the collection bins provided (check with your dealer) to protect the environment.
- The battery can't be replaced by the user, but only by the maker of this product, the after sales department or a qualified person.

SWITCH OFF IN RESTRICTED AREAS

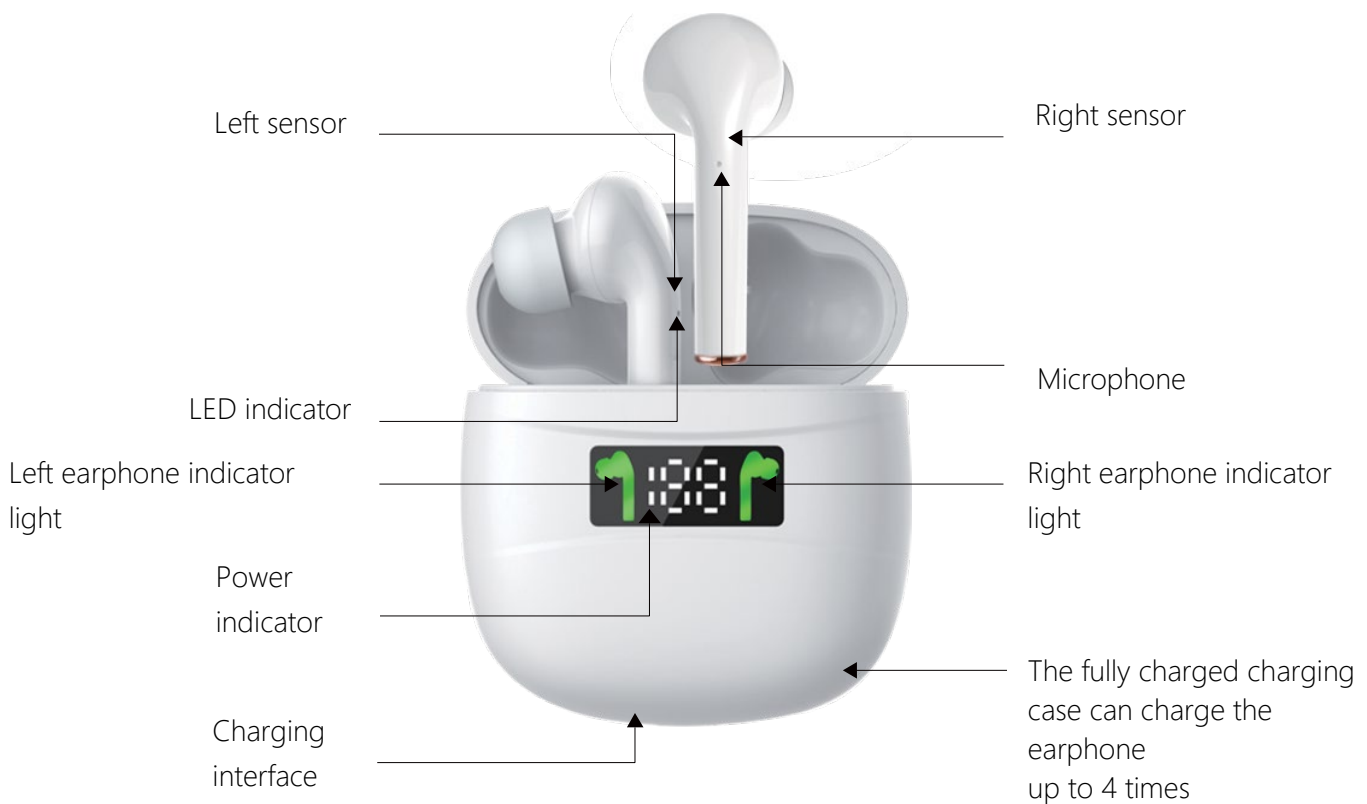

Product presentation



Left sensor

- One-tap: answer / hang up / pause / play
- Double-tap: Volume down
- Triple-tap: switch previous music
- Keep pressing for 2 seconds: Reject
- Keep pressing for 3 seconds: Call Siri
- Turn Off: Keep pressing for 5 seconds to turn off

Right sensor

- One-tap: answer / hang up / pause / play
- Double-tap: Volume up
- Triple-tap: switch next music
- Keep pressing for 2 seconds: Reject
- Keep pressing for 3 seconds: Call Siri
- Turn Off: Keep pressing for 5 seconds to turn off

Bluetooth Pairing

1. Turn on the charging box switch. When charging, the digital screen will flash and the power will increase, and it will stop flashing when the display reaches "100". It means the battery is full.
2. Open the top cover of the charging box and take out the earphones.
3. Pair with other devices: Open the phone or other device Bluetooth settings, search for **the Bluetooth name "BLP4890"**, click to connect to Bluetooth.
4. The headset is placed in the charging box to enter the charging mode, and the headset is automatically turned off.
5. The headset will automatically shut down if it's not connected to Bluetooth device for 5 minutes.

Charging

1. After putting the earphones in the case, the green light will flash twice quickly. Flashing twice means the earphones are detected; then flash slowly for 20 seconds. Flashing slowly means it is in charging.
2. After flashing slowly for 20 seconds, the display screen will enter the sleep state and the light will be off.
3. When the earphones are fully charged, the digital screen will light for 1 second and then be off.
